Note: Actual/Assessed Valuation is multiplied by a Rollback Percentage to get to the Taxable Valuation to calculate Property Taxes. Residential and commercial properties have the same rollback percentage through \$150,000 of actual/assessed valuation.

Reasons for tax increase if proposed exceeds the current:

Sibley saw 14% growth and an increase of almost \$80,000 CGFL dollars. Utilizing our levies to their fullest extent our estimated regular tax rate comes in approximately \$1.26 more than the previous year. These numbers are subject to change and will likely be lowered upon reevaluation of the budget.
